Panelists and Presenters



Neca Aguilar attended Arizona State University where she received her Bachelor of Science in Sociology with a minor in Family and Human Development. She is focused on pursuing a career in business law, with the aspiration of serving as General Counsel. Cindy Thomas Archer joined UCI Law as a Professor of Lawyering Skills in 2020. Prior to her appointment, she was a Clinical Professor of Law and Associate Dean of Clinical Programs and Experiential Education at LMU Loyola Law School, Los Angeles where she was influential in inaugurating the Loyola Social Justice Law Clinic. Passionate about inclusive excellence in education, Professor Archer was inaugural director of Loyola's first generation law student program; chaired not only the law school Equity and Inclusion Committee but was a member of the university President's Implicit Bias Taskforce and served as developer, facilitator and trainer for the university-wide training programs. Throughout her career, Professor Archer has been active in regional and national professional organizations promoting and supporting the work of lawyering skills as a discipline. Professor Archer has lectured on a variety of professional responsibility topics for local bar associations and served on boards and committees of local affinity bar associations.



Kevin D. Ashley, Ph.D., is an expert on computer modeling of legal reasoning. He researches in the field of legal text analytics and studies how to prepare law students for its effects on legal practice. In 2002 he was selected as a Fellow of the American Association of Artificial Intelligence "for significant contributions in computationally modeling case-based and analogical reasoning in law and practical ethics." He is co-editor in chief of Artificial Intelligence and Law and has been a principal investigator of many National Science Foundation grants. He is the author of Modeling Legal Argument: Reasoning with Cases and Hypotheticals (MIT Press/Bradford Books, 1990) and of Artificial Intelligence and Legal Analytics: New Tools for Law Practice in the Digital Age (Cambridge University Press, 2017). He is also a senior scientist at the Learning Research and Development Center, an adjunct professor of computer science, and a faculty member of the Graduate Program in Intelligent Systems of the University of Pittsburgh.

EDC is the lead agency implementing San Francisco's "Tenant Right to Counsel" legislation, a landmark program that guarantees every San Francisco tenant facing eviction the right to a free attorney. Prior to his work at EDC, Mr. Murphy worked at Legal Services of Northern California in Ukiah, providing housing and benefits advocacy to low-income rural families. He also worked at Bay Area Legal Aid in San Francisco where he focused on representing tenants in federally subsidized housing. He has been a member of the California bar since 2013.





Teresa Godwin Phelps is Professor of Law Emerita at American University's Washington College of Law. She has been involved in teaching legal writing and developing legal writing programs for the past thirty years, both at WCL and at the University of Notre Dame Law School. In 1986, she wrote a seminal article, "The New Legal Rhetoric," that has had lasting influence on the way that legal writing is taught. She has served as a member of the Editorial Board of Legal Communication & Rhetoric and of the Board of Directors of the Association of Legal Writing Directors. Her scholarship focuses on the intersection of law and narrative; she has written about the power of legal narratives in areas as diverse as domestic violence and transitional democracy. She has published numerous articles and three books on legal writing, on women and the law, and on transitional democracy and truth commissions. Her book, Shattered Voices: Language, Violence, and the Work of Truth Commissions (University of Pennsylvania Press, 2004), analyzes and evaluates truth commissions through the lens of narrative theory. Her more recent work focuses on the relationship between storytelling and building a human rights culture and on post-conflict remedies for sexual violence against women.



Hilary Reed teaches first year Lawyering Skills and Strategies at the University of Houston Law Center. She also has taught Appellate Advocacy, Trusts and Wills, Education Law, and Professional Writing Strategies, an upper level skills course. Prior to joining UH's faculty, Professor Reed was associate professor of Legal Research and Writing at Pepperdine University School of Law in Malibu, California for a decade. Before she began teaching, she practiced in the Los Angeles office of O'Melveny & Myers LLP.



Lizet Palomera Torres is a 2L at Golden Gate University School of Law. She is a first-generation minority student who attended law school to advocate for underrepresented and marginalized groups. Currently, Lizet is a student-lawyer at the Veterans Legal Advocacy Center and a Law Review Staff Writer. She is also a Lexis Ambassador and an active member of the Public Interest Law Foundation and Latin American Law Student Association. Lizet has received two academic awards, a Witkin award for Online Defamation and a CALI award for Legal Writing and Research II.





Allison Wang is a visiting professor of law, and the Director of Externship Programs at Golden Gate University School of Law. She also serves as Interim Director of Disability Services for both the law school and the university. In her role as Externship Director, she is passionate about connecting students with opportunities to participate in practical training with practicing lawyers or judges. In this role, she increased access to clinical education for part time law students and working students by designing the Bay Area's only Cannabis Law Clinic, and GGU's first Immigration Clinic, in which students work with clients seeking asylum and other forms of humanitarian relief. Prior to joining GGU, she worked in private practice and in the nonprofit sector, where she represented people with mental and developmental disabilities. She also worked as a research and appellate staff attorney at the San Francisco Superior Court and clerked for the Hon. Maria-Elena James in the Northern District of California.



For the past 15 years, **Jacque Wilson** has worked with or mentored USF law students in the Criminal and Racial Justice Clinics. A senior trial lawyer at the San Francisco Public Defender's Office, he serves as the growth and development training director, working with new attorneys, running the intern program, coordinating office training, and handling post-conviction cases. As a trial attorney, Jacque helped reform California's felony murder rule though the passage of SB 1437. SB 1437 significantly narrowed the felony murder rule and has helped many unjustly sentenced individuals gain their freedom. He also mentors hundreds of high school, college and law students through the San Francisco Public Defender's Court Watch program, and is co-founder of Advocates For Justice, a non-profit organization that fights for social, economic and criminal justice.
